Application Forms will be issued on and from 23rd August to 1st September, 2018 between 9.00 a.m. and 3.00 p.m. from the School Counter at the Main Gate (Ballygunge Circular Road entrance) for a payment of Rs. 500/- on submission of a copy of the Birth Certificate of the candidate.

GENERAL INFORMATION:

St. Lawrence High School is a Boys' School affiliated to the Board of Secondary Education, West Bengal. The school prepares students for Madhyamik and H.S. Examinations.

- [A] Stream is English Medium from Class 1 to 12 with First Language: Bengali.
- [B] Stream is English Medium from Class 1 to 12 with First Language: Hindi.

On the Application Form the choice of Stream must be indicated as 'A' or 'B'.

VERIFICATION:

Forms duly filled in should be brought to the school for verification on the designated day. Only parents will accompany the child for the verification session. The date, time and venue of the verification procedure will be printed on the Application Form. Failure to appear for the verification session, with the required documents, at the appointed time, will result in cancellation of the application.

- (b) Employer's Certificate of Income, of both parents. Persons who are self-employed or who have their own business must submit either a *personal* statement, a copy of Income Tax Returns or audited accounts statement of their yearly income.
- (c) Photocopy of a valid document to prove <u>residential address</u>.
- (d) Photocopy of certificate where applicable, of SC / ST / OBC / Baptism.
- (e) One <u>Stamp</u> size colour photograph of the child.
- (f) Copy of <u>Aadhar Card</u> of Father, Mother & Child.
- (g) Proof of blood group of the child.
- (h) Copy of last Report Card of the child.
- PLEASE DO NOT SUBMIT ANY DOCUMENTS OTHER THAN THOSE REQUESTED ABOVE.
- KINDLY CARRY ORIGINAL DOCUMENTS FOR VERIFICATION ONLY.
