  - BROWSE FOR THE FOLDER WHERE THE PDF FILE IS SAVED.
  - OPEN THE FOLDER
  - SELECT THE PDF FILE
  - FOLLOW THE DIALOG BOX AND ATTACH THE FILE
  - SEND
