The School, as advised, is taking steps to file an SLP to the Hon'ble Supreme Court against the said judgement and order dated 13<sup>th</sup> October 2020. Parents may pay fees in accordance with the order of the Honourable High Court of Calcutta dated 13<sup>th</sup> October 2020, which will be accepted by the School without prejudice to its rights.
